This legally binding contract is between the buyer:

This contract is governed by the laws of the State of Florida.

[redacted] initial Aircraft Flying is an activity that is potentially dangerous and can result in serious injury or death. EACH PILOT OR PARTICIPANT, REGARDLESS OF EXPERIENCE, ASSUMES TOTAL RESPONSIBILITY FOR HIS OR HER OWN ACTIONS AND SAFETY AND AGREES TO RECEIVE ANY TRAINING OR TRANSITION TRAINING REQUIRED FOR SAFE OPERATION OF THIS AIRCRAFT

The aircraft being proposed to be purchased is a brand new REVOLT trike light sport aircraft. The above listed purchase price is FOB Florida. Shipping from Florida to alternate location is not included in this price.

[redacted] The above price obtained from the form does not cover sales tax for any state within the US. It will be sole responsibility of the buyer to provide sales tax to appropriate state when and if asked for. If the sale is in state of Florida, the manufacturer will collect sales tax for Florida at the time of delivery.

[redacted] The estimated delivery date is: [redacted] based on the deposit date of [redacted]. Delays caused by acts of nature, changes to order, or delayed payment of funds when required shall not void this contract, and may extend the estimated delivery date.

In the event that payment is not received within 45 days, the order may be cancelled and the purchaser shall forfeit 1/3 of the initial deposit. The 2/3 balance will be refunded when the aircraft is re-sold.

Any dispute or litigation regarding this contract shall be subject to the laws of the state of Florida and shall be litigated in the state of Florida

Buyer agrees to release the manufacturer, dealer and importer of all liabilities arising from the misuse or abuse of the aircraft after sale and understands that flying is a potentially hazardous activity that can result in injury or death.
