This contract is governed by the laws of the State of Florida.

The aircraft being proposed to be purchased is a brand new Rev trike ultralight aircraft.
The above listed purchase price does not include shipping

[redacted] The above price obtained from the form does not cover sales tax for any state within the US. It will be sole responsibility of the buyer to provide sales tax to appropriate state when and if asked for.

Delays caused by acts of nature, changes to order, or delayed payment of funds when required shall not void this contract, and may extend the estimated delivery date.

An initial deposit of \$ [redacted] (50% of the total purchase price), required with contract.
The remaining balance of \$ [redacted] is due approximately 2 weeks prior to the completion.

[redacted] Please note: If the aircraft is being test flown and tuned, this service is NOT included in the delivery date.

[redacted] After notification of final payment due date, the buyer must submit payment within 7 days or the delivery will be delayed. In the event that payment is not received within 45 days, the order may be cancelled and the purchaser shall forfeit 1/3 of the initial deposit. The 2/3 balance will be refunded when the aircraft is re-sold.

Any dispute or litigation regarding this contract shall be subject to the laws of the state of Florida and shall be litigated in the state of Florida

Buyer agrees to release the manufacturer, dealer and importer of all liabilities arising from the misuse or abuse of the aircraft after sale and understands that flying is a potentially hazardous activity that can result in injury or death.
