shall from hereon out be referred to as Buyer, and Distributor/Dealer Evolution Aircraft Inc. a corporate business located at 39440 South Ave, Zephyrhills FL, 33542 from hereon out shall be referred to as Distributor/Dealer/Manufacturer. This contract is governed by the laws of the State of Florida.
Aircraft Flying is an activity that is potentially dangerous and can result in serious injury or death. Each Pilot or participant, regardless of experience, assumes total responsibility for his or her own actions and safety and agrees to receive any training or transition training required for safe operation of this aircraft.
The aircraft being proposed to be purchased is a brand new REV X trike light sport aircraft. The above listed purchase price is for pick up from Florida location. Shipping from Florida to alternate location is not included in this price.
The above price (obtained from the Order Form) does not cover sales tax for any state within the US. It will be sole responsibility of the Buyer to provide sales tax to appropriate state when and if asked for. If the sale is in the state of Florida, Evolution Aircraft, Inc will collect sales tax for Florida at the time of delivery.
The estimated delivery date is: based on the deposit date of Delays caused by acts of nature, supply chain shortages, changes to order, or delayed payment of funds when required shall not void this contract, and may extend the estimated delivery date.
