Each Pilot or participant, regardless of experience, assumes total responsibility for his or her own actions and safety and agrees to receive any training or transition training required for safe operation of this aircraft.

The aircraft being proposed to be purchased is a brand new REVOLT trike light sport aircraft. The above listed purchase price is for pick up from Florida location. Shipping from Florida to alternate location is not included in this price.

The above price (obtained from the Order Form) does not cover sales tax for any state within the US. It will be sole responsibility of the Buyer to provide sales tax to appropriate state when and if asked for. If the sale is in the state of Florida, Evolution Aircraft, Inc will collect sales tax for Florida at the time of delivery.
