# PURCHASE AGREEMENT and LIABILITY RELEASE

## Terms and Conditions:

This legally binding contract is between the buyer (print name):

\_\_\_\_\_ shall from hereon out be referred to as Buyer, and Distributor/Dealer Evolution Aircraft Inc. a corporate business located at 39440 South Ave, Zephyrhills FL, 33542 from hereon out shall be referred to as Distributor/Dealer/Manufacturer. This contract is governed by the laws of the State of Florida.

\_\_\_\_\_ Aircraft Flying is an activity that is potentially dangerous and can result in serious injury or death. Each Pilot or participant, regardless of experience, assumes total responsibility for his or her own actions and safety and agrees to receive any training or transition training required for safe operation of this aircraft.

**The aircraft being proposed to be purchased is a brand new REV X trike light sport aircraft. The above listed purchase price is for pick up from Florida location. Shipping from Florida to alternate location is not included in this price.**

\_\_\_\_\_ The above price (obtained from the Order Form) does not cover sales tax for any state within the US. It will be sole responsibility of the Buyer to provide sales tax to appropriate state when and if asked for. If the sale is in the state of Florida, Evolution Aircraft, Inc will collect sales tax for Florida at the time of delivery.

\_\_\_\_\_ The estimated delivery date is: \_\_\_\_\_ based on the deposit date of \_\_\_\_\_. Delays caused by acts of nature, supply chain shortages, changes to order, or delayed payment of funds when required shall not void this contract, and may extend the estimated delivery date.

**An initial deposit of \$ \_\_\_\_\_ (50% of the total purchase price) is required with contract. The remaining balance of \$ \_\_\_\_\_ is due approximately 2 weeks prior to the completion of the trike carriage.**

\_\_\_\_\_ **Please Note:** If the aircraft is being certified, certification time is **NOT** included in the delivery date.

\_\_\_\_\_ After notification of final payment due date, the Buyer must submit payment within 7 days or the delivery will be delayed. In the event that payment is not received within 45 days, the order may be cancelled and the Buyer shall forfeit 1/3 of the initial deposit. The remaining 2/3 balance will be refunded when the aircraft is re-sold.

\_\_\_\_\_ Any dispute or litigation regarding this contract shall be subject to the laws of the state of Florida and shall be litigated in the state of Florida.

\_\_\_\_\_ Buyer agrees to release the Distributor/Dealer/Manufacturer of all liabilities arising from the use, misuse or abuse of the aircraft after the sale and understands that flying is a potentially hazardous activity that can result in injury or death.

\_\_\_\_\_ Buyer understands that they are required to receive proper training, fly within the operating limitations of the aircraft, follow the maintenance schedule and comply with **ALL** Mandatory Safety Directives.
